Learn to Skate Parents and Skaters:

The St. Cloud Figure Skating Club LTS program is designed around the fundamental principals of teaching kids the mechanics of skating. We make every attempt to do this in a safe and friendly environment. For these reasons, it is sometimes necessary to take the time to point out a few safety reminders for everyone's benefit. Please read these the following reminders which very serious in nature and will be monitored and enforced.

- ◆ The SCFSC will have skating assistants available for skaters who need additional help.
- ◆ The ice is full of kids with various skating capabilities thus games such as tag, chasing around is very dangerous and will not be permitted.
- ◆ Absolutely NO food, beverages, or gum is permitted on the ice or in the player's boxes.
- ◆ Please be courteous of others on the ice at all times as lessons are being conducted during the entire hour
- ◆ Skating aids are designed to be pushed on the ice and should not be ridden.

Dear Parents and Skaters:

The St. Cloud Figure Skating Club (SCFSC) is now in its 36th year and is looking forward to a very exciting year. The SCFSC is a non-profit club run by a Board of Directors with volunteer committees working in many areas. Information on the club's Learn to Skate (LTS) program is in the balance of this letter. Please read the entire letter carefully as it contains much information as gained from previous year's experiences.

Classes for LTS have lesson for 30 minutes and practice for 30 minutes. Skaters work through eight levels of basic skating skills at their own pace.

Classes for USA Hockey classes will have 30 minutes of lesson and practice for 30 minutes. Skaters work through four levels of basic hockey skating skills at their own pace. Before a skater can participate in Hockey Skills, the skater must pass basic skills level 1 as these are the required skills necessary to progress in hockey lessons.

Interested in becoming a Supportive Member of the SCFSC? This membership is for any person, 19 and over who is interested in the advancement and success of the St Cloud Figure Skating Club. Parents of skaters are encouraged to join as supportive members so they can be actively involved in the club. Membership entitles you to one year subscription to Skating Magazine (United States Figure Skating publication) a vote at the SCFSC general membership meeting, the opportunity to be a nominee for the Board of Directors, a copy of all board meeting minutes and upcoming meeting agendas. If you are interested please contact Janelle Loehlein at 420-4633 so the necessary forms can be sent.

Registrations: Registrations will be accepted throughout the year if room is available. Skaters registering on site will be evaluated and placed in a class to begin during the next scheduled class time. The skater may use the first day to practice on the ice.

Lesson Fees: The cost is based on a 22 session program divided into seven equal monthly payments due on the fifth (5th) of each month. You pay for all enrolled scheduled classes whether or not you attend. You are invoiced for the entire amount based on registration date. If you need to cancel your membership you must submit a 30 day notice of cancellation. If no notice is received you will be responsible for the entire amount.

LTS Payment Policy: Payments will no longer be accepted at the LTS Information table. Parents can either mail the payments to P.O. Box 1401, St Cloud, MN 56302-1401 or they can deposit their payment in the payment box located in the Figure Skating Locker room. The payment box is attached to the wall. **Please indicate on the memo line of your check what and whom the payment is for.** Personal checks and money orders are preferred payment methods, please do not send cash. **There will a \$30.00 fee for all returned checks.**

There is no change available during Learn to Skate sessions. Monthly statements **will not** be sent out it is the responsibility of parents/skaters to know what is owed and when the payment is due. If you are unsure about your payments you can contact the Financial Administrator Janelle Loehlein, at 420-4633 cell/ 271-0071 home or jloehlein@stcloudfsc.com. If balance is past due your skater will not be considered in good standing and may not be allowed to participate in certain club activities. **There is a \$25.00 late fee on all past due accounts.**

Rental skates are available through MAC.

Private lessons are available to supplement your skating. They can be set up after your first class. A list of available pros will be available through LTS Director, Amanda Theis.
