## FROM THE CHAIR

Summer is supposed to be a time when we recharge. The end of the school year is often frantic, and one needs a little time to unwind. We hope your summer shapes up to be pleasant and relaxing, and that high oil prices aren't keeping you from your vacation plans.

There is much activity going on here, however, as two faculty are taking up new assignments. Prof. Yasemin Bardakci is leaving the university this fall to take a position at Temple University in Philadelphia. We have benefited from her knowledge in econometrics for the last two years; she will be missed. Prof. Örn Bodvarsson will not be leaving the university or even the department formally, but will take up an assignment as a department chair for the Management Department in the Herberger College of Business. Given the amount of interaction our department has with HCOB, we will undoubtedly benefit from having Örn there.

More good news comes from off campus. First, Jim Bullard has been named president of the Federal Reserve Bank of St. Louis. Jim is a 1984 graduate of SCSU with a double major in economics and quantitative methods and information systems (QMIS, now BCIS.) While I have not done an exhaustive search, I think that is our first graduate to be a Fed president. Second, we saw Prof. Rich MacDonald on CNN as the judge for the Economics Challenge national finals. He said little more than "that's correct" or "that's incorrect", but he looked very, well, judicial. (The Challenge is a high school economics knowledge bowl put on by the National Council for Economic Education, where Rich was the vice president for programs in 2006-07. SCSU hosts the regional contest that starts teams on their way to the finals in New York City.)

Meanwhile, faculty continue to buzz in and out of the office, some to teach summer classes, others to work on research. And all are recharging and getting ready for fall.

## MEET THE PROFESSOR



Professor **Richard MacDonald** returned full time to the department in January after spending the prior 14 months as the Vice President of Programs at the National Council on Economic Education (NCEE) in New York City. While at NCEE, he was responsible for overseeing a multi-million dollar portfolio of economic, financial and entrepreneurship education programs that the non-profit organization had received funding from government, corporate, and foundation donors to create and manage. While Rich does not miss the weekly commute between Minnesota and New York, he remains involved in national and international activities with NCEE and now serves as its Senior Advisor for Program Development.

While economic education is his primary professional focus, Rich's teaching interests remain macroeconomics and money & banking—two areas that have been full of timely educational classroom instructional opportunities over the past several months. With Dr. Banaian, he continues to co-author the St. Cloud Area Quarterly Business Report, which is now in its 9th year, and is circulated to more than 5,000 quarterly readers as part of the ROI Central Minnesota business magazine. Rich lives in Sauk Rapids with his wife and three youngest children and, when time permits, still finds golf and recreational travel to be among his favorite personal activities.
