1.8	Subd. 4. License and rules. (a) The board must adopt rules to license public school
1.9	teachers and interns subject to chapter 14.
1.10	(b) The board must adopt rules requiring a person to pass a skills examination in
1.11	reading, writing, and mathematics as a requirement demonstrate levels of proficiency
1.12	on career and college readiness tests under section 120B.30, subdivision 1, that are
1.13	recommended by the Board of Teaching for admission to a Minnesota teacher preparation
1.14	program or to attain an equivalent composite score composed of the average of the scores in
1.15	English and writing, reading, and mathematics on the ACT Plus Writing, or an equivalent
1.16	composite score composed of the average of the scores in critical reading, mathematics,

A person teaching under a temporary license for two consecutive years 2.1 who does not attain the requisite composite ACT Plus Writing or SAT score during that 2.2 period may receive an initial teaching license if: the person's transcript from an accredited 2.3 college or university shows the person received credit for courses in mathematics and 2.4 writing; and the school administrator who supervised the person during that two-year 2.5 period transmits a signed letter to the board stating that the person is able to perform basic 2.6 job responsibilities requiring reading, writing, and mathematics skills. The requirement to 2.7 demonstrate the requisite levels of proficiency on state career and college readiness tests 2.8 or attain the requisite composite score on the ACT Plus Writing or SAT does not apply to 2.9 non-native English speakers, as verified by qualified Minnesota school district personnel 2.10 or Minnesota higher education faculty, who, after meeting the content and pedagogy 2.11 requirements under this subdivision, apply for a teaching license to provide direct 2.12 instruction in their native language or world language instruction under section 120B.022, 2.13 subdivision 1. (c) The board must adopt rules to approve teacher preparation programs. The board,
upon the request of a postsecondary student preparing for teacher licensure or a licensed
graduate of a teacher preparation program, shall assist in resolving a dispute between the
person and a postsecondary institution providing a teacher preparation program when the
dispute involves an institution's recommendation for licensure affecting the person or the
person's credentials. At the board's discretion, assistance may include the application
of chapter 14.

2.23 (d) The board must provide the leadership and adopt rules for the redesign of teacher 2.24 education programs to implement a research based, results-oriented curriculum that focuses on the skills teachers need in order to be effective. The board shall implement new 2.25 2.26 systems of teacher preparation program evaluation to assure program effectiveness based on proficiency of graduates in demonstrating attainment of program outcomes. Teacher 2.27 preparation programs including alternative teacher preparation programs under section 2.28 122A.245, among other programs, must include a content-specific, board-approved, 2.29 performance-based assessment that measures teacher candidates in three areas: planning 2.30 for instruction and assessment; engaging students and supporting learning; and assessing 2.31 student learning. The board's redesign rules must include creating flexible, specialized 2.32 teaching licenses, credentials, and other endorsement forms to increase students' 2.33 participation in language immersion programs, world language instruction, career 2.34

and technical programs, Montessori schools, and project and place-based learning, among
 other career and college ready learning offerings.

(e) The board must adopt rules requiring candidates for initial licenses to pass an 3.3 examination of general pedagogical knowledge and examinations of licensure-specific 3.4 teaching skills. The rules shall be effective by September 1, 2001. The rules under this 3.5 paragraph also must require candidates for initial licenses to teach prekindergarten or 3.6 elementary students to pass, as part of the examination of licensure-specific teaching 3.7 skills, test items assessing the candidates' knowledge, skill, and ability in comprehensive, 3.8 scientifically based reading instruction under section 122A.06, subdivision 4, and their 3.9 knowledge and understanding of the foundations of reading development, the development 3.10 of reading comprehension, and reading assessment and instruction, and their ability to 3.11 integrate that knowledge and understanding. 3.12

3.13 (f) The board must adopt rules requiring teacher educators to work directly with
3.14 elementary or secondary school teachers in elementary or secondary schools to obtain
3.15 periodic exposure to the elementary or secondary teaching environment.

(g) The board must grant licenses to interns and to candidates for initial licenses
based on appropriate professional competencies that are aligned with the board's licensing
system and students' diverse learning needs. The board must include these licenses in a
statewide differentiated licensing system that creates new leadership roles for successful
experienced teachers premised on a collaborative professional culture dedicated to meeting
students' diverse learning needs in the 21st century and formalizes mentoring and induction
for newly licensed teachers that is provided through a teacher support framework.

3.23 (h) The board must design and implement an assessment system which requires a
3.24 candidate for an initial license and first continuing license to demonstrate the abilities
3.25 necessary to perform selected, representative teaching tasks at appropriate levels.

3.26 (i) The board must receive recommendations from local committees as established3.27 by the board for the renewal of teaching licenses.

(j) The board must grant life licenses to those who qualify according to requirements
established by the board, and suspend or revoke licenses pursuant to sections 122A.20 and
214.10. The board must not establish any expiration date for application for life licenses.

(k) The board must adopt rules that require all licensed teachers who are renewing
their continuing license to include in their renewal requirements further preparation in
the areas of using positive behavior interventions and in accommodating, modifying, and
adapting curricula, materials, and strategies to appropriately meet the needs of individual
students and ensure adequate progress toward the state's graduation rule.

4.2 services for disabled children, the board shall adopt rules consistent with license or
4.3 registration requirements of the commissioner of health and the health-related boards who

(d) The Board of Teaching, consistent with board rules, must issue up to threeone-year temporary teaching licenses to an applicant who:

(1) successfully completed all exams and human relations preparation componentsrequired by the Board of Teaching; and

(2) holds or held an out-of-state teaching license to teach the same content field
and grade levels, where the scope of the out-of-state license is no more than one grade
level less than a similar Minnesota license, but has not completed field-specific teaching
methods or student teaching or equivalent experience.

7.18 The applicant may complete field-specific teaching methods and student teaching
7.19 or equivalent experience by successfully participating in a one-year school district
