- 2.5 cumulative GPA

Notes:

- Refer to Degree Audit Report for Liberal Education goal area options and requirements
- Complete two 200-level foreign language courses or test out
- All 300-400 level business courses require upper division status. Exceptions may be made if student needs additional courses to create a full time schedule and have met other GPA and prerequisite requirements.
