Central Lakes College to St. Cloud State University Transfer Guide

All transfer students seeking a business degree from St. Cloud State University must consult with an advisor in the Business Advising Center to determine their status in the School. Requirements for HBS upper division status¹ (see list below)

1. Minimum GPA of 2.65 or higher. Transfer GPA can be used if all requirements are met prior to a GPA being established at SCSU.
2. 45 earned credits. Includes all transfer credits and SCSU credits. Does not include developmental coursework.
3. Completion of the following: ACCT 291, HBS 111, ENGL 191, CMST 192, MATH 196

ACCT 291	ACCT 2011	Need C- or better. 2.40 GPA and 12 credits are required to register for course at SCSU.
HBS 111	N/A	Not required for students with 20 or more transfer credits.
ENGL 191	ENGL 1410 & 1411	
CMST 192	SPCH 1431	Other Goal 1 SPCH courses will be accepted in lieu of CMST 192.
MATH 196 ²	MATH 1470 (equivalent to MATH 112)	Need C- or better. In lieu of MATH 196, the Business School will accept advanced math courses (i.e. calculus based) or a transfer of College Algebra (MATH 112).

4. Completion or enrollment of the following: ACCT 292, IS/STAT 242, BLAW 235, CSCI/CNA 169, ECON 205, ECON 206, HBS 211

IS/STAT 242	N/A	Need C- or better. 2.40 GPA and 12 credits are required to register for course at SCSU.
BLAW 235	BUSN 2541	2.40 GPA and 12 credits are required to register for course at SCSU.
CSCI/CNA 169	COMP 1101 OR 1120	Need C- or better.

² If student will not be transferring the required math they should complete developmental math courses through Intermediate Algebra (equivalent to MATH 072 at SCSU) or have scored at least a 60 on the Accuplacer College Level Math test. Students who do not meet these requirements will be subject to SCSU's math placement guidelines. Postponing math preparation will create a delay in graduation.

³ Courses taken from a 2-year school will not transfer to SCSU as equivalent to a 300 or 400-level business course.

⁴ Must be taken in final semester and all other core classes must be complete.
