*Please complete this form only if you intend to submit your <u>STEM OPT Extension</u> application <u>online</u> to USCIS. We will review your answers on this form and may recommend corrections before filing via USCIS. If you plan to mail your application to USCIS, please read the <u>STEM OPT</u> instructions on our webpage for mail-in requests.



ATTENTION! Do not submit your application to USCIS without requesting STEM OPT via Center for International Studies first. Your STEM OPT request must be processed by CIS before submitting your application. An international student advisor (DSO) will issue you a new I-20 showing STEM OPT "requested" on top of page 2. Incomplete and inaccurate submissions to USCIS increase your likelihood of rejection.
