

## GENERAL MANUSCRIPT COLLECTIONS

1. **Alderink, George (1889-1977).** Papers, (1955-72), 2.5 in.  
Alderink served as State Representative from District 55, from 1954 to 1958. Collection includes some correspondence, legislative reports, and subject materials. {S1815}
2. **American Association of University Professors.** Records, 10 in.  
Consists of newsletters, reports, 1984 manual, education bill, post-secondary reports, membership, general correspondence, and financial information. {S2116}
3. **American Association of University Women, St. Cloud Branch.** Records, (1922- ), 3.6 ft.  
Collection includes annual reports, bulletins, secretary notebooks, and meeting minutes. Scrapbooks cover numerous years of the organization's existence. Collection is added to periodically. {S60}
4. **American Legion Auxiliary - Wallace Chute Post No. 76, St. Cloud, Minn.** (1962-63), one volume.  
One scrapbook which includes newspaper clippings, programs, and various awards of the organization. {S1884}
5. **American Visions.** (1986)  
This debut issue commemorates the first celebration of Dr. Martin Luther King, Jr. with a national holiday. {S2069}
6. **Anderson, Jerald (1934- ).** Papers, (1966-77), 4 in.  
Anderson was a DFL State Senator from District 19, serving on the Education, Finance, and Judiciary Committees. The majority of the collection deals with education, with some correspondence and newspaper clippings. {S1842}
7. **Association of Central Minnesota Teachers of History.** Records, (1971-80), 5 in.  
The Association of Central Minnesota Teachers of History was established in 1971, with the help of SCSU faculty, to establish a stronger bond between teachers of history in Central Minnesota and to strengthen the position of history in the programs of Central Minnesota schools. The organization was dissolved in 1980 with the formation of the Minnesota Association of History Teachers. The collection contains the Association's constitution, meeting minutes, newsletter, newspaper clippings, correspondence, announcements, and newsletters from the Committee on History in the Classroom (1972-76). {S2045}

8. **Blacksmithing Account Book.** (1866-72), one volume. {S1844}
9. **Boehm, John C. (1860-1929).** Papers, (1894-1926), 10 in.  
Boehm was a doctor in St. Cloud beginning in 1894. His papers include numerous receipts and documents, dated 1902-1926. A journal of Dr. Boehm's patients, from 6 July 1894 to 18 March 1895 is included. {S2083}
10. **Brainerd Community Chest.** Records, (1943-50), 2 in.  
This collection consists of minutes, by-laws, and incorporation papers. {S1982}
11. **Brotherhood of Railroad Trainmen, St. Cloud.** (1948-60), two volumes.  
Meeting minutes, membership lists, cash records, and quarterly reports. {S84}
12. **Brotherhood of Railroad Trainmen, Ladies Auxiliary, St. Cloud Branch.**  
Records, (1921-46), 5 in.  
This collection contains correspondence, legislative reports, and booklets from the organization. Prominent community leaders of the 1930's and 40's are portrayed. {S65}
13. **Brown, Andrew A. (1873-1938).** Papers, (1866-1938), 1 in.  
Brown lived in Douglas County, where he dealt with real estate. Of particular interest in the collection is the correspondence from then-congressman John Lind. There are numerous land grants and certificates, along with a copy of the *Alexandria Post*, 25 October 1878. {S1803}
14. ***Bulletin of Atomic Scientists.*** (1985)  
40<sup>th</sup> Anniversary issue. {S2070}
15. **Buscher, Dr. Julius, M.D. (1891-1963).** Papers, (1919-63), 2.1 ft.  
Buscher was born in Germany in 1891 and served as a medical officer in the German Army in World War I. He came to St. Cloud in 1929 where he practiced medicine at the St. Cloud Hospital and the Veterans Hospital. The collection is mostly about medicine, with some correspondence, and items concerning naturalization. Collection is Restricted, contact Center for details. {S66}
16. **Central Minnesota Historical Assembly.** Records, (1966-96), 1.5 ft.  
Records include annual meeting minutes, correspondence, membership lists, treasurer's reports, the Assembly's constitution, and information regarding the counties of Central Minnesota. {S2044}
17. **Central Minnesota Loan & Building Association.** (1891-93), one volume.

This large ledger holds entries and transactions for residents of the St. Cloud area. Some prominent St. Cloud business names, such as Cooper, Mitchell and Zapp, are recorded. {S2002}

18. **Charles, Russ and Ruth, Medicine Show.** Papers, (1981-94), 2.5 in.  
Russ and Ruth Charles are St. Cloud natives who traveled with a medicine show early in their career and have produced their own traveling magic show since the 1940s. The collection consists of video tapes of their performance, an oral history interview, newspaper and magazine clippings, and miscellaneous photos, posters and brochures about Russ and Ruth and their show. {S2108}
19. **City of St. Cloud, Bids and Election Returns.** (1949-61, 1964-67), 3.75 ft.  
This collection consists of two sections. Section I includes advertisements for bids, and rejected bids. Section II consists of general, primary and special election returns, summaries, and related material. {S62}
20. **City of St. Cloud, Miscellaneous Permits.** (1963), 2.5 in.  
This collection consists of miscellaneous permits issued by the City of St. Cloud in 1963. {S1819}
21. **Civil War Diaries of Thomas N. Roberts, 28<sup>th</sup> Iowa Regiment.** (April 1863-August 1865), 1 in.  
This collection is the transcripts of original diaries held by the donor and photocopies of two letters. {S2010}
22. **Clawson, John T. (1945- ).** Papers, (1971-84), 11.8 ft.  
Clawson was a State Representative from District 19 (Chisago, Isanti, and Kanabec Counties) from 1975-1985. Collection includes constituent and subjects correspondence on numerous topics. Also included are newspaper clippings, campaign materials, and newsletters from various sources. {S1841}
23. **DFL Materials.** (1954-64), 8 in.  
Consists largely of political pamphlets and posters for the Democratic-Farmer-Labor Party for 1954-64. Also included are computer voter information sheets, updated. {S99}
24. **DFL Records.** (1967-73), 1.4 ft.  
Materials of major topics make up the bulk of the collection. Contains such items as newsletters, pamphlets, legislative reports, and newspaper clippings, most of the mass-mailing type. {S89}
25. **DFL Records, Sherburne County.** (1972-82), 6 ft.

Contains various materials from both the county and state level. Included are newsletters, election results, convention proceedings, and information on individual candidates. Also includes materials used by the St. Cloud Chapter of the McCarthy for President Committee during the 1968 presidential race. {S2008}

26. **East Side Boosters Club (St. Cloud, MN).** Records, (1933-73), 2.5 in.  
The East Side Boosters Club promoted business and civic interests of East St. Cloud. Includes correspondence, newspaper clippings, promotional materials, and a general history of the organization. {S1893}
27. **Election Tally Sheets, Benton County.** (1932 and 1934), 2 in.  
This collection contains tally sheets and poll lists for the 1932 and 1934 elections in Gilmanton Township in Benton County. {S2058}
28. **Farming Township Account Books.** (1919-60), two volumes. {S1924}
29. **General Reference Material.** 1.75 ft.  
This collection contains a variety of reference material: *The Illustrated History of Odd Fellowship* (1914), *Daily News Almanac & Political Register* from the *Chicago Daily News* (1889), parts 1-14 of 32 of *A History of the United States* magazine series, and parts 2-12 of 50 of *The Illustrated Catalogue of the Masterpieces of the United States, 1876 International Exhibition, Philadelphia*. {S28}
30. **Grand Central Hotel (St. Cloud, MN).** One volume.  
This guest register contains the names and addresses of hotel guests for 27 September 1902 to 4 November 1902. It also includes clippings about movies and movie stars for the pre-World War I era. {S1808}
31. **Granite City Savings and Loan Corp. (St. Cloud, MN).** Records, (1894-1945), 5 in.  
The three volumes in this collection include board of directors meeting minutes, stock certificates, and stock ledgers. {S95}
32. **Graves, Carlton.** One volume.  
Carlton Graves has been a veterinarian for the Rice, Minnesota community for many years. Part of his receipt book contains a list of his receipts for 1972. Another part of the receipt book contains the treasurer records for the local St. Cloud Chapter of the Grand Army of the Republic's encampment fund of 1891. {S1988}

33. **Hardware Store Records and Catalogs.** (1857-1934), 1.25 ft.  
This collection consists of business information from Proctor and Clark Co.; Smith and Herbert; Weber's; Lockwood Manufacturing Co.; Marshall Wells and Hardware Co.; Jenny Semple, Hill and Co.; J.G. Read and Brothers Co.; Hibbard, Spencer, Bartlett and Co. {S94}
34. **Harren, Henry M. (1922- ).** Papers, (1961-72), 4 ft.  
The majority of this collection is reports and pamphlets from legislative bodies on pertinent topics. The Minnesota Outdoor Resources and Recreation Commission (MORRC) is featured prominently in the collection. {S56}
35. **Heuer, William C. F. (1905- ).** Papers, (1954-66), 1.25 ft.  
The bulk of the collection is constituent correspondence from Heuer's District 54, which included both Todd and Wadena counties. Also included are materials from the Todd County Committee for the Minnesota Statehood Centennial. {S1931}
36. **Hill City Land, Loan, and Lumber Company (Aitkin County).** (1903-07), one volume.  
This is a company record book that contains material dealing with the transfers of various plots of property. {S1984}
37. **Historic Heartland Association.** (1974), .5 inch.  
Three issues of a publication about Native American Minnesota history. {S86}
38. **International Association of Machinists and Aerospace Workers.** Records, (1950-84), 6.25 ft.  
Donated by Jerome L. Burnett, former IAM Grand Lodge Representative, this collection includes the organizing activities of the IAM in mostly Minnesota and Wisconsin companies. Also included are various union publications, convention proceedings, lodge rosters, and a personal file on Mr. Burnett. {S1849}
39. **International Eucharist Congress.** (1926), two volumes.  
One of the volumes in this collection is a book prepared as a souvenir for the XXVIII International Eucharist Congress held in Chicago in 1926, the first International Eucharist Congress to be held in the United States. It gives a history of previous Congresses and Catholic Chicago. The other book, which was sponsored by the Burlington Rail of Chicago, describes the program of the Congress and explains various means of transportation and accommodations for the 1926 Congress. {S2004}

40. **Isanti County Savings and Loan Association Records.** (1894-1924), one volume.  
This large account book contains minutes, annual reports, and articles of incorporation. {S1981}
41. **Knife Lake Township (Kanabec County, MN).** Records, (1907-48), 2.5 in.  
Election records, road and ditch records, treasurer's reports, and wolf and fox bounties are included in this collection. Various legal documents are also included. {S1980}
42. **Kosloske, John T. (1907- ).** Papers, (1949-71), 10 in.  
Kosloske was the mayor of Sauk Rapids, a state legislator, and also served as a Justice of the Peace. This collection is comprised largely of legislative correspondence on a variety of subjects. {S55}
43. **Lorsung, Peter, Monsignor.** Papers, (1935-56), 2.5 in.  
Monsignor Lorsung served as parish priest in several churches in Central Minnesota. The collection includes ordination materials, church reports, and newspaper clippings. {S1869}
44. **Marshall, Frederick (1906-1985).** Papers, (1948-66), 20.8 ft. and four volumes.  
Marshall was the U.S. Representative from District 6 from 1948 to 1960. His papers include legislative materials, newspaper clippings, constituent correspondence, and voting records. Also included is material from Marshall's tenure on the National Commission on Food Marketing. {S30}
45. **Massmann, John.** Papers, (1964-85), 1.8 ft.  
John Massmann is a retired Professor of History from SCSU. His papers include personal documents; information on city issues, such as the 10th Street Bridge and the South/Southeast Neighborhood Association; and NSP power plant information. {S2119}
46. **McKelvy, James M. & Family.** Papers, (1857-63), 1.25 ft.  
James M. McKelvy served in the Seventh Minnesota Infantry Regiment during the Civil War. His son, James E., served in the Thirteenth Minnesota Infantry Regiment during the Spanish-American War. The collection includes correspondence, military records, and newspaper clippings. {S2}
47. **Merchants Hotel (St. Cloud, MN).** One volume.  
This guest register contains the names and hometowns of patrons of the Merchants Hotel from 18 March 1903 to 27 June 1903. {S1985}

48. **Miller, Melvin, J. (1919-1974).** Papers, (1972-74), 5 ft.  
Miller was a state representative from District 12A. He died shortly after his re-election in 1974. His papers include constituent correspondence, legislative materials, newspaper clippings, and copies of bills. {S1986}
49. ***Minnesota Economic Data, Counties & Regions.*** (1966-73), 1 in.  
This collection consists of twenty-one issues of this publication series which was generated from a research program at the University of Minnesota which began in January 1966. The publications were prepared by the Department of Agricultural Economics, the Agricultural Extension Service, and the Agricultural Experiment Station. The issues were published on an irregular basis as the data was collected. This collection contains issues between October 1966 and April 1973 (issues 1-22, missing 17 and 20). {S2052}
50. **Minnesota Legislative Reports, etc.** (1948-66), 5 in.  
This collection consists of the Report of the Constitutional Commission of Minnesota and the Report of Bipartisan Reapportionment Commission. {S91}
51. ***Minnesota Pocket Data Book.*** (1973)  
This volume contains data and trends of the state of Minnesota. The information includes population, commerce and economic indicators, human resources, education, natural resources, pollution control, outdoor recreation, government, and transportation. {S2053}
52. **Minnesota State Reformatory For Men, St. Cloud, MN.** Records, (1889- 1938), 5 in.  
This collection consists of annual and biennial reports for the St. Cloud State Reformatory for the years 1889-1937. Other miscellaneous publications are included, such as The Pillar, an in-house newsletter. {S68}
53. **Morgan, John D. (1844-1920).** Papers, (1849-1919), 17.5 ft.  
Morgan was a surveyor and produced numerous survey maps of Central Minnesota. These maps, which include general surveys, and drainage ditch maps, make up the majority of the collection. Also of interest are materials from the Chippewa Land Examination, 1902-03. {S31}
54. **National Association for the Advancement of Colored People (NAACP), St. Cloud Chapter.** Records, (1983- ), 2.5 in.  
Collection consists of meeting minutes, announcements, and a copy of the constitution for the local chapter. Several issues of *The Crisis* are also included. Collection is added to periodically. {S2041}

55. **National Railroad Adjustment Board.** (1939-63), 129 volumes.  
These volumes contain the records of grievances settled between the Brotherhood of Railroad Trainmen, the Brotherhood of Locomotive Firemen and Enginemen, and various railroad companies. Two volumes of indexes are included. {S61}
56. **Nelsen, Bruce G. (1935- ).** Papers, (1979-82), 1 ft.  
Nelsen was a state representative from the Staples area from 1975-1983. His papers include constituent correspondence, news releases, and legislative memos. {S2006}
57. **Nolan, Richard M. (1943- ).** Papers, (1975-80), 117 ft.  
Richard Nolan represented the Little Falls area in the Minnesota House of Representatives from 1969 to 1973. He was elected to the U.S. House from the Sixth District in 1974, and served until 1981. This collection includes correspondence, newspaper clippings, news releases, case files, and other legislative materials. This collection is Restricted, contact Center for details. {S88}
58. **Northern Pacific Railway Company.** Pamphlet collection, (1869-1967), 5 ft.  
This collection consists of a variety of pamphlets, advertisements, reports, etc., from the Northern Pacific Railroad. These include annual reports, president's addresses, and publications that were used to encourage immigrants to move to the Upper Midwest area. {S29}
59. ***The Northwest Magazine.*** (1891-1900).  
The Northwest Magazine was an illustrated monthly publication "devoted to western interest and progress." It was published in St. Paul, Minnesota, by E.V. Smalley. The main focus was to encourage settlement of the remaining land in the western United States. {S2117}
60. **Patton, Al (1933- ).** Papers, (1972-76), 5 in.  
Al Patton was a state representative from District 17A from 1973 to 1981. His papers include constituent correspondence, information on the then-proposed dome stadium, and various legislative materials. {S1959}
61. **Pehler, James C. (1942- ).** Papers, (1970-91), 6.5 ft.  
Pehler was a state representative from District 17B from 1973-1991. This collection includes newspaper clippings, constituent correspondence, news releases, and other legislative materials. {S33}
62. **Petersen, Hjalmar.** Papers, (1918-69), 1.25 ft.  
Hjalmar Petersen was a former lieutenant-governor, governor, and Railroad & Warehouse Commissioner. This collection consists mainly of personal correspondence between Petersen and his wife and daughters. Also



included are materials from the 1936 governor race, and his disagreement with Elmer A. Benson. {S69}

63. **Pine City Elementary World War II Unit, sixth grade.** One volume.  
Consists of materials regarding the rationale, methods, materials, and evaluation of a World War II unit for the Pine City Elementary sixth grade. {S2130}
64. **Plat Book Collection.**  
Includes plat books for Benton, Stearns, Sherburne, Todd, and Pope counties. {General Map Collection}
65. **Politics and Elections.** (1879-1936), 2 in.  
This collection consists of political material and election material from 1879-1936. It includes poll lists, election results, campaign material for the major parties, political books, messages, bills, etc. {S1809}
66. **Psychology Department History.** (1956-94), .5 in.  
An oral history interview tape and transcript of Al Krueger, SCSU Psychology Department faculty. {S2109}
67. **Recount Trial Records.** (1962, 1963), 10 in.  
This collection consists of 20 volumes of transcript proceedings for the court trial of Rolvaag, et al No. Andersen in the election of governor in Minnesota in 1962. {S1821}
68. **St. Cloud - the City and Its Organizations.** (1868-1935), 5 in.  
This collection includes financial records of the St. Cloud Union Band, St. Cloud assessors, and the St. Cloud School District; three St. Cloud directories (1888-89, 1894-95, 1908-09); a history of the North Star Lodge (1907); and a history of Tech High School (1935). {S93}
69. **St. Cloud Area Council of Governments.** Records, (1972-78), 10 in.  
Donated by the League of Women Voters, this collection contains material dealing with the Metropolitan Advisory Council and the St. Cloud Metropolitan Area Planning Commission (later the Council of Governments). {S1917}
70. **St. Cloud Area Environmental Council.** (1976- ), 4in.  
Contains the meeting minutes of the St. Cloud Area Environmental Council, starting 1976. This collection is added to periodically. {S1850}

71. **St. Cloud Citizens, Inc.** Records, (1949-53), 2 in.  
Records include the mailing list of the Board of Directors, the Articles of Incorporation, application for membership cards and miscellaneous correspondence of the organization. {S1991}
72. **St. Cloud Education Directories.** (1957-95), 1.8 ft.  
This collection consists of thirty-one volumes of the St. Cloud Public Schools Directory from 1957-58 to 1991-92, and twenty-five volumes of the Diocese of St. Cloud School Directory from 1964-65 to 1995. Both sets are incomplete. {S2118}
73. **St. Cloud Humane Society.** Records, (1893-91), two volumes.  
This collection contains a small booklet of the Society's Articles of Incorporation and a ledger of the Society's minutes and newspaper clippings. {S1807}
74. **St. Cloud Labor Records Lodge 623.** (1965-72), four volumes.  
Four scrapbooks containing programs, membership lists, photos, newspaper clippings, constitution and by-laws, and award citations for the Senior Citizens club from the years 1965-72. {S1883}
75. **St. Cloud State University Public Relations File.** 10 in.  
This collection consists of individual files of newspaper articles on persons associated with St. Cloud State University. The majority of the clippings are from the 1970s. {S101}
76. **St. Cloud Union Band.** Records, (1894-1900), one volume.  
This account book contains the financial records of the band, lists events for which the band played, and identifies which members played at which events. {S2049}
77. **St. Cloud Voter Registration Cards.** (1926-32), 1.7 ft.  
Only names beginning with the letter "S" through "Z" are included. {S1810}
78. **St. George Township (Benton County).** Records, (1859-1968), 2 ft. and five volumes.  
These records include election results, birth and death registers, minute books, road and bridge books, and treasurers' journals. Pursuant to Minnesota Statue 144.225, these records are Restricted. Contact Center for details. {S1993}

79. **St. John's Episcopal Church (St. Cloud, MN).** Records, (1856-1978), 6 ft.  
 Founded in 1856, St. John's Episcopal Church is the oldest church in St. Cloud. These records include St. Anne's Altar Guild, treasurers' books, secretary minutes, Improvement League materials, and Church Aid Society. {S1840}
80. **St. Monica Christian Mothers.** Records, (1940-77), 2 in.  
 The St. Monica Christian Mothers were organized at St. Francis Xavier Church in Sartell in 1940. The collection consists of newspaper clippings, lists of members and committees, an historical sketch, and a public relations file. {S2036}
81. **Samuelson, Donald (1932- ).** Papers, (1968-72), 3 ft.  
 Don Samuelson has represented the Brainerd area as a state representative and senator since 1968. His papers include constituent correspondence, newsletters, newspaper clippings, and legislative publications. {S1836}
82. **Schumann, Marvin C. (1906- ).** Papers, (1955-68), 3 ft.  
 Marvin Schumann served as state representative from the Rice, Minnesota area from 1955-1968. Included in his papers are constituent and legislative correspondence, and other legislative materials. {S70}
83. **Sherburne County Star-News (Elk River, MN).** (1889-1930), 1.5 ft.  
 Contains issues of the *Sherburne County Star-News* for the years 1889-1899, 1902-1930. Not all sets are complete. Check inventory for details. {S2025}
84. **Sherwood, Glen (1934- ).** Papers, (1972-81), 2.25 ft.  
 Glen Sherwood was a state representative from District 4B from 1972- 1981. In 1979 he became noted for switching from the DFL to the Independent Republican Party, claiming the DFL-ers were becoming "too liberal". His papers include constituent correspondence, newspaper clippings, and other legislative materials. {S1947}
85. **Staples, Minnesota, Organization Records.** (1901-47), 2.5 ft.  
 This collection contains records of various organizations in Staples, Minnesota: the Crescent Lodge (Masonic Lodge), the American Red Cross Association, the Ship by Rail Association, the Commercial Club, and Civic and Commerce Association. {S1948}
86. **Stearns County Biographical Sketches.** (1936-41), 4 ft.  
 The Minnesota Works Progress Administration during the Great Depression conducted several thousand interviews across the state. This collection consists of the approximately 1,500 interviews taken in Stearns County. {S1}

87. **Stearns County Independent School No. 28.** (1889-95), one volume.  
One treasurer's book. {S93}
88. **Stearns County Old Settlers Organization.** Records, (1896-1923), 2.5 in.  
The Old Settlers Organization of Stearns County was organized in St. Joseph in January 1896. This collection contains a book of plans for annual dinners 6 June 1905 to 7 December 1917, and a ledger of meeting minutes, by-laws, and member lists, including some receipts. {S96}
89. **Stearns County School District #1894.** Records, (1910-67), 10 in.  
Bound volumes make up the bulk of this collection. Volumes contain clerk's records, school attendance records, and text book records. {S24}
90. **Sullivan, John D. & Henry H.** Papers, (1911-76), 2.5 in.  
John Sullivan, and his son, Henry H., served as state representatives from District 45. Their years of service spanned three decades. The collection includes newspaper clippings, campaign materials, and a typed biography. {S50}
91. **Thaibault, Romauld B. (1918- ).** Papers, (1889-1980), 6.5 ft.  
This collection contains numerous items relating to the Brotherhood of Railroad Trainmen, the United Transportation Union, and their relationships with various railroad companies. Other materials include some personal correspondence, case files, and union agreements. {S2082}
92. **Thirteenth Minnesota Infantry Regimental Association.** (1929-32), 5 in.  
Contains the programs for the 25th, 27th, 28th, 32nd, and 34th annual reunions of this famed regiment. Some years contain multiple copies. {S59}
93. ***Times-KFAM Weekly Letter To Servicemen.*** 86 issues, (20 December 1943 - 10 September 1945).  
This newsletter was published by the St. Cloud Daily Times during World War II, and sent to all Central Minnesota persons in service. Issues included news briefs from the area, plus information on area service people and their activities. A name index is available. {General Newspaper Collection}

94. **Todd County School District #787 (Browerville Township).** Records, (1912-78), 4 ft.  
This collection consists mainly of clerks and treasurers' record books, along with information pertaining to the Browerville chapter of the Parent- Teacher Association. Also included are school bulletins, school board minutes, and other miscellaneous items. {S78 & S2031}
95. **Todd County School District #2321 (Iona Township).** Records, (1889-1970), 2 ft.  
These records include clerk records, term and attendance registers, librarian records, and other items. {S79}
96. **Todd County School District #2355 (Little Elk Township).** Records, (1912- 65), 1 ft.  
This collection contains clerk records, 1919-1965, and treasurer's records, 1912-1953. The records are not complete for the years given. {S77}
97. **Transcontinental Railroad Exploration, U.S. Senate Report.** (1853-55), 2.5 in.
