

WHAT ARE THE MOST IMPORTANT PROBLEMS FACING THE STATE? 2011

- Respondents were also asked to indicate what they feel is the biggest problem facing the state today. The top six problems facing the state, according to our respondents are, from the top, unemployment/job opportunities (22%), budget and budget deficit (20%), the economy (14%), education funding and quality (9%), and politics/politicians and taxes were tied (6%). In 2010 the top five were: the economy, budget and budget deficit, unemployment/job opportunities, education funding and quality, and taxes. In 2009, the top five were: health care, budget, education, unemployment, taxes. In 2008, the top five were education, taxes, financial/mortgage crisis, unemployment, health care. In 2007, education, taxes, health care, roads, crime. In 2006, education, taxes, health care, crime, roads.
- We then asked the respondents which party they believe can do a better job of fixing that issue. An examination of the top six problems this year and which political party can do a better job of fixing them, we found the respondents were more likely to see Republicans doing a better job tackling the budget and taxes but Democrats were seen to better tackle the economy, education and unemployment/jobs. These findings are similar to last year; the only addition is respondents were split in who they saw better dealing with the issue of politics and politicians.

PRES. ELECTION

- **The President** has a comfortable 13% lead among all Minnesotans which narrows to a still comfortable 8% lead among likely voters. As noted below other statewide polls are finding the same margins. However this is what is called a "fluid opinion" [some say snapshot] and can change.
- In most demographic groups the President either has a slight advantage to a large advantage in groups such as women.
- The President has the advantage in most of the demographic areas with the <u>exception</u> of {note some of the breakdowns have small n's and should be interpreted very carefully]: 45-64 year olds [for the first time the survey breaks out the 65+ into 65-74 and 75+]; those Minnesotans with some college education; Baptists (Catholics and Lutherans are evenly divided); and among self-identified conservatives
- By gender he does slightly better among males but very well with females [about an 18% difference].
- **Governor Romney** does best with Republicans, those with some college education, conservatives, and Baptists.

MARRIAGE AMENDMENT

- Those Most Likely to Favor the Marriage Amendment
- Republicans, conservatives, those who say religion is very important in their lives, respondents over 65, Baptists
- Those Most Likely to Oppose the Marriage Amendment
- 7 of 10 Democrats, liberals, moderates, college graduates
- About evenly split Catholics, Lutherans, education, most age groups up to 65 years of age, moderates
- There appears to be some movement toward opposing both.
 Remember not voting is a no vote. It will probably take a majority over 54% or so and not a plurality for an amendment to pass.
