Associate of Applied Science (AAS) in Criminal Justice to Bachelor of Arts in Criminal Justice

Transfer Process

All transfer students seeking a Bachelor of Arts in Criminal Justice should follow the admission procedures located on the following website in order to be admitted to St. Cloud State University (SCSU): www.stcloudstate.edu/transfer. More information can be found in the [University Catalog](#).

The following AAS Criminal Justice courses transfer *from* Central Lakes College to SCSU:

The following AAS Criminal Justice MnTC courses will transfer in to fulfill SCSU MnTC Goals Areas:

SOCL 2481 Race Ethnicity & Oppression (Goal 5 & 7)	SOC 268 Race & Ethnicity
COMM 2420 Intercultural Communication (Goal 1S & 7)	CMST Transfer

**If a student completes ENGL 1410 at Central Lakes College instead of ENGL 1410 AND ENGL 1411, ENGL 1410=ENGL 100 at SCSU; transfer students coming in with ENGL 100 will be required to take ENGL 291 (2 credits) Intro to Analytical and Rhetorical Writing at SCSU upon transfer to complete the Goal 1: Written Communication requirement for the MnTC at SCSU.

It is recommended that students take these courses as part of the Minnesota Transfer Curriculum (MnTC).

If a student completes a Goal area within the MnTC, the same Goal area will be complete at SCSU once transferred.

Additional Requirements to Consider when Degree Planning:

- Completion of 10 Goals (40 credits) in the MnTC (known as the Liberal Education Program at SCSU)
- 40 upper-division credits (300-400 level coursework) are required to graduate from SCSU
- Completion of three Diversity classes. (Maybe adjusted depending on the amount of transfer credits). One diversity course must be an approved Racial Issues Graduate Requirement (RIGR) course (see Goal 7 for RIGR courses)
- Complete Residency Requirement. 30 credits must be earned at SCSU
- Earn a minimum of 120 credits to graduate with a bachelor's degree
- Must maintain a major GPA of least 2.5 after being admitted
- Additional major course requirements to be taken at SCSU
