- Mitch Karstens Director of Atwood
 - o Atwood comprehensive plan (10 year) Hoping to finalize by the second week of February
 - Lower level Changes to the underground (gaming systems, cosmetic upgrades, wider opening), the Quarry (remove bar, redo lighting and sound), cosmetic upgrades in the loft and the Den, two new meeting rooms in the previous Valhalla space, remove two meeting rooms and create a rehearsal space.
 - o Entrance "from Garvey" addition will be added creating a new entrance.
 - o Book store and "swag" shop would come into Atwood.
 - Main Floor finishes in the theater lounge and lighting changes, Non-traditional student space in the student collaboration area, add in a freight elevator, rearrange the back of house area where semi's dock.
 - o Top Floor − 2019 picking up space from some groups moving into Eastman, IT will move to the top floor rather than in the basement, Cascade room − upgrade lighting and sound, Ballroom − create a space out from for people to check in for an event, freshen up the stairways, small meeting rooms will be taken out and changed to one large room that can be divided into three, another large meeting room from the addition.
 - o Currently has 3 bonds on the building. 2 will be paid off in 2021, not until this time can they get another bond.
 - Working with MANY focus groups to complete this project.
 - o New signage for Atwood: all new exterior signage once the weather is cooperative. Already have new graphics on the entry way doors.

- Feedback on new food venues since this Fall: they really like the build your own pizza, working on grab options, burrito bowl is still very popular, Main floor concepts are still doing very well, still working on improving the speed of service.
- o Individuals within the cultural center said that they want their separation that they have, yet they want to be seen greater. Looking at doing a glass wall within the next several years.
- Vice President Shelly
 - o Officially sent a letter of resignation
 - Currently a Director on the board for Students United there are no current bylaws in our
 constitution declaring who can hold this position. If the senate approves Kayla Shelly would like
 to continue this position.
 - Normally with this resignation the President Pro Tempore would take the position. The current member declined the position. Due to this Chairs will nominate those who they feel should have this position. Voting would be next week. Vote must be 60% yes.
