## Open Gallery I

- Denis Mergen Director of Lindgren Child Care Center
  - The Lindgren Child Care Center is currently at full capacity and even have children on waiting lists.
  - o The Enhancement grant allowed them to stay open until 9 pm at night to be able to look after children of students who have night classes
  - Students have the opportunity to observe children and see how they develop over the time they spend at the LCC
  - o They have one teacher in each class room along with having students working at the center
- Jean Dempsey
  - o There are many opportunities for nontraditional students on campus to connect with each other
  - The program- Chat and chew meet at Gravey Commons for nontraditional students to talk about anything with other nontraditional students while having a meal for free.
  - The website Bridge to benefits is there for financial aid for nontraditional students, it provides them with forms and people to contact in their local area
  - They are piloting a space for students who are overwhelmed with poverty and the space will help them take the necessary steps for help so they can complete their education
  - Wants student government support to let admin know this is important because it shows admin cares for students. They want to have students feel like it is okay to get help/support.
- Mitch Karstens and Jen Matzke
  - o Presenting a potential model for new meal plans for fall 2018
  - Want to enhance the value of meal plans for students
  - Want to accommodate all students on campus from those who stay nearby to those who commute

- o Found they are the most expensive in the system
- The system now is complicated due to all the options and want to stream line it for the ease of students
- o Presented a new model while looking at meals of the plan, husky bucks
- o Meal plans for on campus living potentially be the anytime meal plan which has remained stable and have brought down the price and changed to the husky 170 and 120.
- o They want to have an add-on option for more blizzard bucks to add on to a meal plan
- o Have new options for voluntary meal plans to be made in line with student purchases
- Retail concepts rely on the students to spend and gives another option for something different and get out of Gravey commons. This is the reason why husky bucks is included with the meal plan
- o In the vendor meal plans students buy the plan that works for them
- o RHA have supported the idea to reduce the number of meal plans, believe this new plan will accommodate a variety of students, however they were wondering about marketing strategies
- o Goal is to be implemented in the fall, searching for approval and feedback
- Opening Stearns Hall at a lower price point and does not require a meal plan, and exploring options with Chartwells for a lower meal plan for the Hall
- o Students can add a meal plan at anytime but does not allow for a varying cost.
- o Able to add a meal plan on their student account with in the first week of classes
- o Looking in to the option of take n' bake with meal plans
