She brought a power point to cover Title IX with Student Government.

Title IX is 37 words. This legislation eradicated the narrow minded thinking of what students can do in their education based on their gender or sexual orientation. Title IX goes down to the very start of education. There are 11 mandated things the university is required to do.

Our title IX collaborates with SCTCC, Sexual Assault Center, Counseling and Health Services, Police, Public Safety, Hospital, Student Employment, Faculty and Staff, Res Life, Athletics and other Student Organizations, City and County Attorney, Women's Center, Registrar, CAPS officer, and disability.
